Course objectives, teaching and learning methods and learning outcomes

The aim of the course is to provide fundamental information on intellectual property rights (hereinafter: IPRs), such as: copyright and related rights, trademarks, industrial design, geographical indications and patents. The course is focused on IPRs enforcement. It emphasizes the importance of proper utilization of IPRs and the advantages of appropriate intellectual property management.

After completion of the course the students will be able:

- 1. to identify IPRs most commonly used on the market
- 2. to determine the subject and the scope of copyright and related rights protection
- 3. to determine the subject and the scope of patent protection
- 4. to describe mechanism of industrial design protection
- 5. to explain the importance of trademark management in market competition
- 6. to interpret the relation amongst geographical indications and famous traditional products
